

As previously announced in LTB Memo FY 2020-1, dated December 4, 2019, the Alabama Department of Transportation (ALDOT), through a cooperative effort with the Federal Transit Administration (FTA), and the University of Alabama, Huntsville (UAH) is pleased to announce that the UAH Office of Public Transportation (OPT) is now operational and open for business. ALDOT has contracted with UAH for the Office of Public Transportation to provide support services to ALDOT and its subrecipient public transportation providers.

ALDOT is retaining core competency through inhouse staff, with the UAH OPT providing award, invoicing and FTA drawdown support, as well as regional coordinators to assist ALDOT and our subrecipient public transportation providers with various support services for the administration and management of our programs.

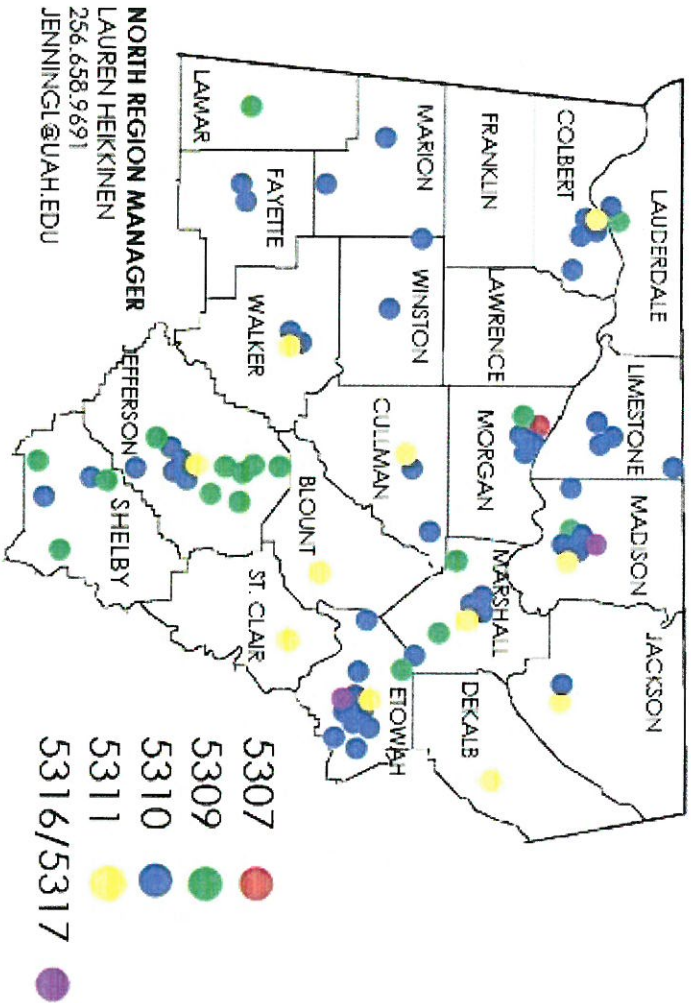

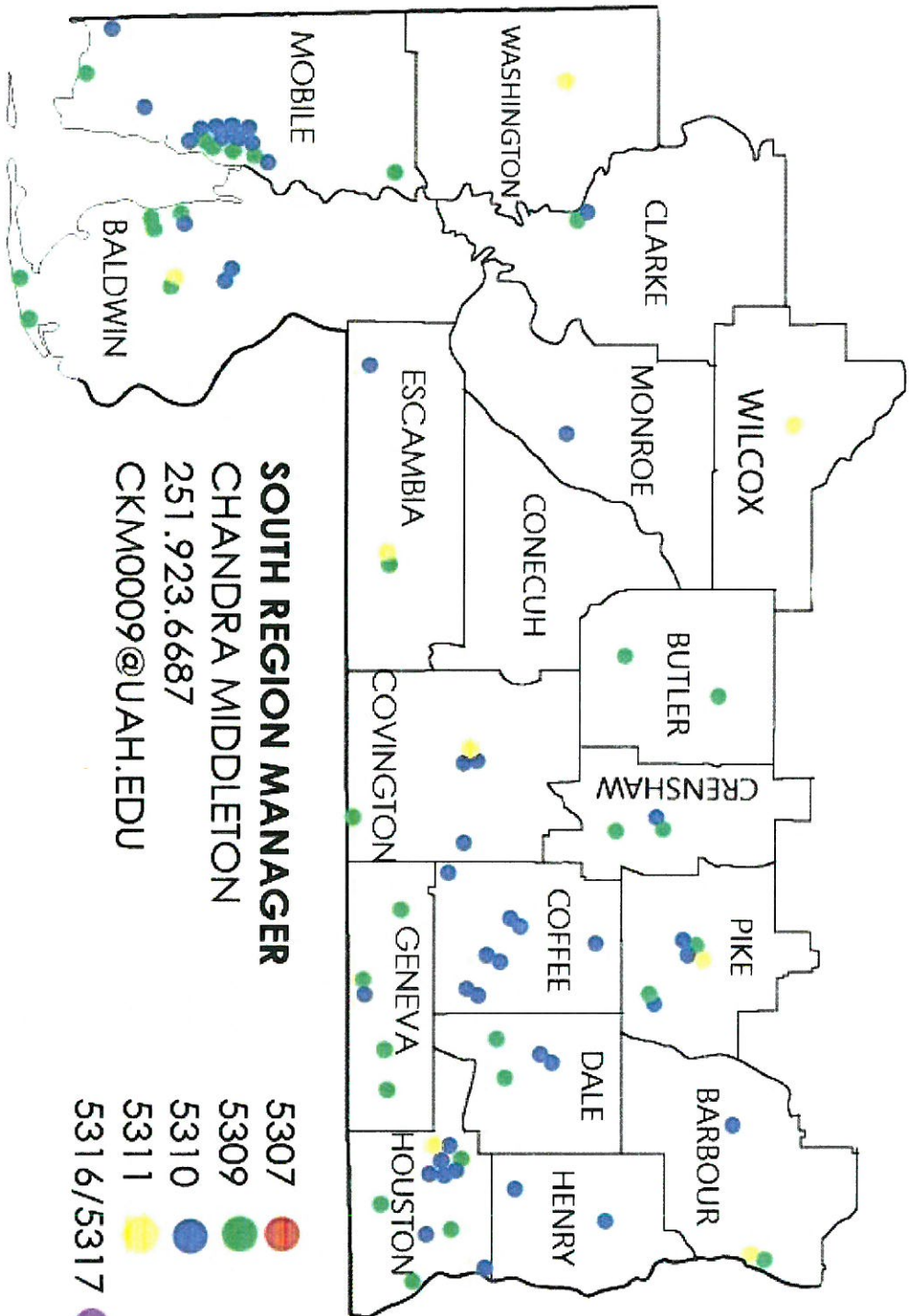
